- Submissions needs to be on the mail id provided to shortlisted teams

### **EVALUATION CRITERIA FOR ROUND-II**

- The submissions will be evaluated on the following parameters:
- Exhaustive understanding of the industry and its financial analysis;
- Recommendation with the stock pitch;
- Valuation of the stock along with the basis of assumptions taken;
- Structure of presentation & clarity of ideas conveyed;
- Completeness / comprehensiveness of the analysis
